A range of financial assistance is available to families of children with disability as well as support that is available to all families.

Where do I start?

Every family is different and the financial support available to you will depend on your individual circumstances. It can be complex working out what assistance you and your family might be eligible for. For information and advice, start by contacting:

Financial support for families and carers

Carer Allowance

This is a fortnightly payment for parents or carers providing extra daily care for an adult or dependent child with disability or medical condition. It is subject to an annual income test, but no assets test. It is not taxable and can be paid in addition to wages, Carer Payment, or other income support payments. https://www.servicesaustralia.gov.au/individuals/services/centrelink/carer-allowance

Carer Payment

This provides financial help to people who are unable to work in substantial paid employment because they provide full-time daily care for someone with severe disability or medical condition. This payment is income and assets tested.

Carer Supplement

This is an annual lump sum payment. It helps with the costs of caring for a person with disability or a medical condition. You will get Carer Supplement if you are receiving Carer Payment or Carer Allowance.

Child Disability Assistance Payment

This is an annual lump sum payment that helps with the costs of caring for a child with disability. https://www.servicesaustralia.gov.au/individuals/services/centrelink/child-disability-assistance-payment

Companion Card

This card is issued to people with a significant, permanent disability, who can demonstrate that they are unable to access most community activities and venues without attendant care support.

Carer Card

This card offers discounts from businesses, government and community organisations, 50% off public transport and for travel on weekends.

Carer Adjustment Payment

A one-off payment to assist families following a catastrophic event where a child younger than seven is diagnosed with a severe disability or severe medical condition.

Financial support to cover health costs

Medicare

Medicare helps with the costs of seeing a doctor, getting medicines and accessing mental health care.

Healthcare Card

A concession card to get cheaper medicines and some discounts if you get a payment from Centrelink. You don't need to apply for a Health Care Card, if you're eligible a card is posted to you.

PBS Safety Net Card

When you reach the threshold you can apply for a PBS Safety Net Card. This card lets you get cheaper medicine for the rest of the year.

Continence Aids Payments Scheme (CAPS)

A yearly payment to help with the cost of continence products for children who are not eligible for the NDIS. Call 1800 239 309

Essential Medical Equipment Payment

A yearly payment to help with energy costs to run medical equipment or medically required heating or cooling. https://www.servicesaustralia.gov.au/individuals/services/centrelink/essential-medical-equipment-payment

GP Management Plan

This supports people with a chronic or terminal medical condition who would benefit from a structured approach to the management of their care needs. Ask your GP for more information.

Chronic Disease Allied Health Services

A Medicare rebate is available for up to five services per patient each calendar year to people who have a chronic (or terminal) medical condition with a GP Management Plan and Team Care Arrangements. Ask your GP for more information.

Mental Health Care Plan

This is a treatment plan that lets you claim up to 10 sessions each calendar year with a mental health professional. If your health professional decides you're eligible, you can have an extra 10 group sessions. Health professionals set their own fees - if they bulk bill, you won't have to pay anything but if they charge a fee only some of the costs are covered. Ask your GP for more information.

Child Dental Benefits Schedule

This covers part or the full cost of some dental services for children if you get certain government payments. https://www.servicesaustralia.gov.au/individuals/services/medicare/child-dental-benefits-schedule

Financial support for families

Family Tax Benefit

This is a two-part payment that helps with the cost of raising children:

- Family Tax Benefit (FTB) Part A is paid per child and the amount depends on your family's circumstances.
- Family Tax Benefit (FTB) **Part B** is paid if you're a single parent or non-parent carer, a grandparent carer, or if you're a member of a couple with one main income.

Child Care Subsidy

This payment is made to your child care service to help with the cost of child care if you are working, looking for work, or if you receive Carer Payment. It applies to children aged 13 and younger as well as children with disability aged 14 to 18 in secondary school who need supervision.

Escaping Violence Payment

This payment is available to help women who are escaping violence and experiencing financial stress. Support can include up to \$1500 in financial assistance and goods and services such as removalists, bonds or basics for a new home.

Financial support for children and young people with disability

Disability Support Pension

This provides financial help if you are between 16 and Age Pension age and have a permanent physical, intellectual or psychiatric condition that stops you from working.

This is for full-time students aged between 16 and 25 who had a Carer Allowance Health Care Card on the day before they turned 16. It gives you cheaper medicines and extra discounts.
